

### Scientific Paper (Oral Presentation)

An oral presentation (5 minutes in length) that summarizes the details of original investigative research. Required abstract format: Introduction/Purpose, Materials and Methods, Results, Conclusion.

Scientific Paper abstracts may include one graphic file with a maximum of two images.

### Scientific Poster (Printed)


Once again this year, SNIS will hold oral poster sessions enabling attendees to ask questions of you about your work. A visual presentation of scientific studies that summarizes the details of original investigative research. Required abstract format: Introduction/Purpose, Materials and Methods, Results, Conclusion.

Scientific Poster abstracts may include one graphic file with a maximum of two images.

### ePoster (Electronic)

An electronic presentation of scientific studies that summarizes the details of original investigative research. Required abstract format: Introduction/Purpose, Materials and Methods, Results, Conclusion. Please note that these are interactive electronic posters, not PowerPoint presentations. Authors who are accepted for this ePoster format will have a secondary ePoster submission process with associated deadlines to display their work electronically in a searchable ePoster Viewing site.

### **ABSTRACT SUBMISSION INSTRUCTIONS**

### **Abstract Submission Criteria**

#### Text:

- 1. Published or previously presented works should not be submitted.
- 2. Submit abstract in one category only.
- 3. Format abstract text using headings required for submission category.
- 4. Maximum length: 500 words; Graphic file equals 100 words; Table equals 50 words.

### **Graphics** – For each abstract submitted:

- 1. Only one graphic file with a maximum of two images is permitted.
- 2. Required Graphic file resolution is 300 dpi or greater.
- 3. Maximum size of printed file is 3 in. by 3 in.

  Note: A submitted graphic that is larger than the required size will be reduced accordingly, which may significantly reduce the quality of the graphic.
- 4. Only jpg or gif formats are accepted online.

### **Important Information for All Abstract Submissions**

- 1. *The Journal of NeuroInteventional Surgery* (JNIS) has first right of publication of papers accepted for presentation at the SNIS 14th Annual Meeting.
- 2. Presenters of accepted abstracts must register for the SNIS 14th Annual Meeting. Registration fees are required and not waived with acceptance.
- 3. Oral papers must be presented in digital format uploaded to our meeting server if accepted. (No personal PC or Mac may be used from the podium).
